The person or persons that are appointed as Estate Trustee and Executor of this my Will, whether original or substituted, shall be referred to in this document as "my Trustees".

SURVIVORSHIP

5. I declare that a beneficiary hereunder does not survive me for a period of at least THIRTY (30) days after my death.
